Single Trash Hauler - Update

The ad-hoc One Trash Hauler neighborhood committee has been working to reduce the number of garbage trucks on our roads. The goal is to reduce the heavy truck traffic to minimize road damage. And, especially on Winans Drive, to make the road safer for all the young children biking and playing on the road.

As of this month, a majority of neighbors have made the switch. Two-thirds of the homes on the north side of the Lake are now using The Garbage Man. While there are still have four different companies operating on the south side, two of those - Advanced and Waste Management - have only one customer each left on Winans Drive.

Overall, nearly 70% of households around the lake have switched to The Garbage Man. We have nothing against any of the companies, The Garbage Man was selected because it is less expensive, collects trash, recycling and yard waste with the same truck and is a local company out of Brighton.

Please consider joining your neighbors in making the switch.

Proposed Winans Lake Drainage District

ISSUE: WLA members have expressed concerns about the drainage of sediment into Winans Lake via Teahen and other roads for many years. The development of Winans Woods and additional houses along Teahen exacerbated the drainage concerns, which include:

 Significant untreated sediment causing excessive aquatic vegetation and forming "muck bars" along the northernmost portions of Winans Lake

- Excess water from Winans Woods subdivision killing trees in the "frog bog" north of Old Drive and seasonally flooding Old Drive
- Runoff along Cowell Road from Chilson to Pleasant Lake Road

In 2018, the WLA board formed a Sedimentation & Stormwater Runoff/Drainage Committee (SSRC) to define the overall issue, review past efforts, and investigate possible solutions. After meetings with Dr Jude (Freshwater Consultants), Hamburg Township and Livingston County Road Commission officials, the committee most recently met with the Livingston County Drain Commissioner. After several meetings and legal review, the Drain Commissioner recommended that the residents affected by the sedimentation petition for establishment of a drainage district. Ten residents filed such a petition with support from the WLA board.

PROCESS: The drain commission accepted the petition; next steps include:

- The drain commission hired an engineer to delineate a proposed district based on topography. The engineer has inspected the area and prepared a preliminary improvement plan and cost estimate.
- After meeting with the WLA Sedimentation and Stormwater Runoff Committee, the scope was defined as:
 - Pave 2,200 feet of Teahen Road with curb and gutter. If practical, divert water to depressions west of Teahen Road.
 - Add/improve sediment traps, check dams, forebays and retention ponds/ditches to better handle stormwater along Cowell Road from Chilson to Pleasant Lake Road
 - Address flooding at the east end of Old Drive. Lower the water level in the "frog bog" east of Old Drive to historical levels prior to the construction of Winans Woods.
 - Replace the culverts under Chilson Road with a box culvert to improve fish spawning west of Chilson Road.
 - Ongoing maintenance of these structures, plus the outlet to Gutt Lake.
- The Drain Commissioner will determine if the drainage district is practical and delineate a potential drain centerline. His staff will prepare a second petition to establish the district.
- Upon acceptance of the second petition, the Drain Commissioner appoints an independent Board of Determination. Detailed design is completed and costs estimated. Criteria for apportioning cost are proposed based upon



- benefit (benefit includes handling storm water from upstream lots that otherwise have to contain onsite most of the rainwater falling on the lot).
- After receiving bids and calculating costs, the Drain Commissioner holds a
 Day of Review (a public meeting to hear comments on the project,
 including the apportionment of benefits and assessment of costs). The
 Drain Commissioner can make revisions based on the comments and any
 objections. The costs being reasonable per the Board of Determination,
 construction will start. After completion, remaining funds will be used to
 maintain structures, etc. in perpetuity.

COST: All properties within the drainage district must participate in paying for improvements, but the amount can vary greatly. Apportionment criteria may include lot size, soil types, how much impervious surface drains toward the lake and the point at which that water is released, improvement of lake access, slopes, lake frontage, etc.

Cost will be determined after engineering plans are put out for bid. A percentage of costs will be borne by Livingston County and by Hamburg Township. The remaining percentage will be assessed to the approximately 500 lots within the Winans Lake drainage district. (Due to the private nature of Winans Lake, resident percentages will be higher than if the lake was public. These percentages have yet to be determined for this project.) Funding will be used that spreads costs over twenty years for individual assessments.

As an example, if \$2,000,000 (conceptual estimate from LCDC) is needed for the overall district, the individual assessment could average \$140 per year for 20 years. Most lots would probably be assessed less, with those lot owners receiving the most direct benefit paying more. Those benefiting most include property owners along Teahen (who will have a paved road), property owners along Cowell and Teahen (who contribute significant amounts of stormwater onto the roads rather than retaining onsite), lakefront properties significantly affected by sedimentation (who will probably cede some property rights to the drain commission) and all lakefront owners (who will have improved water quality and fish habitat). The individual assessments would be added to winter tax bills from the township.

OUTREACH: WLA members who want more information are invited to contact the subcommittee at <u>SSRC@WLA.org</u> with a phone number and a brief note of your concern (the appropriate member will call you). It is anticipated that an informational meeting will be scheduled with the Drain Commissioner and the public hearing noted above as the Day of Review.



Before that formal process, the Sedimentation and Stormwater Runoff Committee would like to hear from you via a zoom meeting. We are planning to schedule such a meeting before year end. Details of the meeting will be communicated in the near future.
