### **Lily Pad Management**

Water Quality Committee

LILY PAD REMOVAL (manually)

Intensive Use and Periodic Manual Clearing of shoreline areas is an effective means of aquatic plant control in small beach areas. The rooted plants must produce sufficient food in their leaves to maintain their root systems. Frequent cutting of the pads or their destruction by wading will eventually lead to root system death.

This technique is particularly effective with emergent vegetation such as water lilies. Like weeding the garden, it is necessary to watch for the early development of potential problems and remove the plants as they become established and before they spread over a large area.

The best hand tool to remove lily pad roots is a pitch fork (5-tine fork). Roots can be loosened and levered out of muck and sand. Once freed the roots float and can be raked or picked and removed from the lake.

This same method works well on water shield, which is a miniature lily pad about the size of a donut.

LILY PAD REMOVAL (chemically)

Some residents use a rake, hoe, or pitchfork to control lily pads along their shore. Other residents cut off the pads periodically thus weakening roots until the pads die off. Pads grow differently depending upon lake bottom. They grow best in silt and muck and least in sand and gravel. A few residents have asked about removal of lily pads using chemicals. Following is a situation description, regulations, and viewpoints including a plan, method, costs, and time line as requested.

The Department of Environmental Quality (DEQ) allows a lake front resident to employ chemical treatment (1) to have a lane to open water no wider than 20 feet and (2) to have a swim beach area no larger than 40' X 40'. The lane and swim area cannot be side by side. They must overlap.

Out of the 84 lake homes many residents have employed manual raking and cutting of lily pads and have cleared a lane or lane and beach area. Under DEQ rules they do not qualify for further lily pad removal by chemical treatment. A fall survey shows that only 12 lots qualify under DEQ Aquatic Nuisance Control permit rules for a partial lily pad chemical treatment program.

"Grooming" is not allowed by the DEQ permit. That means if you have some spots of lily pads along your frontage you do not qualify for chemical treatment if you already have a lane or beach clearing. The lily pads along Chilson Road are not eligible for treatment since no owner accesses there.

Some residents value the lily pads and don't want control or clearance. Our lake advisors, Freshwater Physicians, advise against lily pad removal for reasons of eco-system and habitat. They note that such removal opens the way to other invasive plants and native weed growth.

Our lake treatment company, ATI (Aquatic Technologies Inc.), also notes that lily pad removal leads to the proliferation of other plant species such as watershield, a smaller floating leaf plant which we have here at Winans Lake and which does invade cleared shallow beach areas. Other submerged weeds also invade. ATI notes that periodic maintenance is required to maintain a beach.

If chemical treatment of some lily pads is possible under DEQ guidelines and if a resident agrees and seeks such treatment; then, ATI supplies the following information regarding that treatment:

- (1) The application of a glyphosate product would occur during the month of June. Lily pads would die down in a week or two although some re=growth would occur in later months. The following two years would require June treatments as well until the permitted area was entirely cleared of lily pads and watershield. After three years, subsequent years may or may not require re-treatment.
- (2) Presuming that six residents choose to treat. The cost estimate is \$300 or less\_ per lot for the first year. This assumes that DEQ approves and that the lot owner pre-pays the fees to ATI who will secure a DEQ permit for each lot, identify each lot to be treated, and provide a chemical use table and map.
- (3) The entire lake does not have to be posted. The LGCC beach can remain open. Local posting is required at treatment sites. Water usage for watering lawn and garden adjacent to the treatment area might be restricted for the resident and neighbors for 24 hours. Pet watering should be avoided during that 24 hour period along with swimming and wading at the site which can resume the second day after treatment.
- (4) Owners choosing to treat will have to mark their lot to indicate the area of treatment or provide the ATI treatment group with latitude to make that decision for them. After treatment ATI will verify the lots treated to WLA and provide Aquatic Nuisance Control treatment reports to the DEQ office identifying lots, amounts, results, and adverse effects if any.

### TIME LINE FOR TREATMENT PREPARATION:

5-25-2017 - WLA action date for notification at annual meeting. Such lily pad removal actions are direct contracts between the resident and the lake applier (ATI) with mandatory disclosure of action to WLA. The resident pays ATI directly. ATI secures DEQ permits.

6-05- 2017 - Lot owner has notified ATI ((Scott Jorgenson ATI@aol.com)). ATI has inspected and approved action based upon DEQ guidelines. ATI has owner approved diagram of work and owner has pre-paid ATI.

June 2017 - WLA provides ATI lake access at the beach and a monitor there for the day while ATI is present on the lake.

July 2017 - ATI inspects treated sites, creates & files DEQ treatment reports.
